NOTICE IS HEREBY GIVEN that the Annual Stockholders' Meeting of HOUSE OF INVESTMENTS, INC. will be held virtually on Monday, August 17, 2020, with the proceedings livestreamed and voting conducted via remote communication or *in absentia* through the Company's secure online voting facility.

Pursuant to the alternative modes of notice as provided for in the Securities and Exchange Commission's NOTICE dated April 20, 2020, this notice to stockholders shall be published in the business section of two (2) newspaper of general circulation, in print and online format, for two (2) consecutive days. Given the current circumstances, stockholders may only attend and participate in the meeting by remote communication and vote only by proxy or electronically *in absentia*. For voting via proxy, duly accomplished proxies shall be submitted by email to the Office of the Corporate Secretary at hi_asm2020@hoi.com.ph, for inspection, validation, and recording at least ten (10) days before the Annual Stockholders' Meeting, or on or before August 7, 2020. Proxies received thereafter shall not be recognized for the meeting.

Further details on the procedures for attending and participating in the meeting through remote communication, for casting of votes and the proxy form format are set forth in the Information Statement.

The Company shall record the Annual Stockholder's Meeting and post the same in its website.
